

RESOLUTION 2007-11-10

EMERGENCY TEMPORARY APPROPRIATION

WHEREAS, an emergent condition has arisen with respect to the Township of Cherry Hill and no adequate provision has been made in the FY 2008 temporary appropriations for the aforesaid purpose, and N.J.S. 40A: 4-20 provides for the creation of an emergency temporary appropriation for the purpose above mentioned, and

WHEREAS, the total emergency temporary resolutions adopted in the FY 2008 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S. 40A: 4-20) including this resolution total \$ 12,996,570.50 in the Current Budget and total \$ 806,796.67 in the Sewer Budget.

NOW, THEREFORE BE IT RESOLVED that in accordance with the provisions of N.J.S. 40A:4-20 the following emergency appropriations be approved and that one certified copy of this resolution be filed with the Director of Local Government Services.


